Historical reports incur a one-time charge of \$185.00. **Some feeds require multiple reports.** Adjustments after 60 days from inception are billed at \$85.00. All fees will be billed to the dealer unless ProQuotes is notified otherwise at time of setup. The dealership will always be considered the client, regardless of the source of payment, and will have final say on implementation and/or continuation of services to vendor. Data is not to be disseminated for any other use than the approved above. ProQuotes reserves the right to cancel feed at will for any reason including but not limited to non-payment and/or unauthorized dissemination.
